## NOTE TO USERS

Approved requests for changes will be shown on the final printed FIRM.

## ELEVATION DATUM

Flood elevations on this map are referenced to the North American Vertical Datum of 1988. These flood elevations must be compared to structure and ground elevations referenced to the same datum. 
